- 一、畢業總學分數為 36 學分。
- 二、必修 9 學分，選修 27 學分。
- 三、學生修讀所屬學院之「學院共同課程」應認列為本系專業課程學分；修讀所屬學院之「學院跨領域課程」或其他學院開課之課程，則認列為外系課程學分。
- 四、系所訂定條件（學程、檢定、證照、承認外系學分及其他）：
  - (1) 博士班研究生除依本校學則規定辦理休學外，修業年限以二至七年為限。
  - (2) 論文擇一學期修讀，以通過學位考試方式登錄成績。
  - (3) 第一學年每學期不得少於 3 學分，不得多於 18 學分。
  - (4) 至其他研究所及外校系所選修學分至多承認畢業學分 6 學分，外籍生經系所同意至其他研究所及外校系所選修全英授課學分至多承認畢業學分為 9 學分，其餘外籍生修讀非本系開設之英語授課課程(含線上課程)，經申請後由系務會議認列通過，可認列為畢業學分且不受承認外系學分數上限限制。
  - (5) 至少選修一門全英授課之課程。

**Notes:**

1. Minimum credit required to graduate: 36.
2. Required courses: 9 credits; elective courses: 27 credits.
3. Credits earned by students from the common courses offered by their respective colleges shall be accepted as their affiliated department's professional courses. However, credits earned from interdisciplinary courses offered either by their college or by other colleges will be accepted as credits earned from departments outside their own.
4. Conditions Set by the Department (Program, Certification, Licenses, Credit Recognition from Other Departments, and Others):
  - ① Ph.D. students, aside from following the university's regulations regarding leaves of absence, are limited to a period of study between two and seven years.
  - ② The Thesis must be completed in a chosen semester, and the grade will be recorded based on passing the degree examination. must be completed in a chosen semester, and the grade will be recorded based on passing the degree examination.
  - ③ In the first academic year, students must take at least 3 credits per semester and no more than 18 credits.
  - ④ Up to 6 credits from courses taken in other departments or universities may be recognized towards graduation. International students, with departmental approval, may have up to 9 credits of courses taught entirely in English from other departments or universities recognized towards graduation. For other international students, non-departmental English-taught courses (including online courses) can be applied for and, once approved by the department meeting, will be counted towards graduation credits without being subject to the maximum limit for credits from other departments.
  - ⑤ Students must take at least one course taught entirely in English.
